On January 5, 2022, the Court entered a Decision and Order on the Plaintiffs' Motion for Partial Summary Judgment Regarding the Legality of City Ordinances and SIA Provisions Imposing "Franchise-Fees" (Count I) (Ct. Doc. 99). The Court granted Plaintiffs' Motion for partial summary judgment and ruled that Plaintiffs are entitled to a partial summary judgment providing for (1) a declaration that the "franchise fees" are unlawful; (2) a declaration that any provisions in the SIA relating to Plaintiff's property and purporting to obligate Plaintiffs to the SIA is an illegal sales tax and unenforceable; and (3) an injunction prohibiting the City from imposing these taxes in the future on Plaintiffs. Based upon the Court's Decision and Order, the Court enters the following partial summary judgment:

## IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. Partial Summary Judgment is entered in favor of Plaintiffs Gary McDaniel and Susan McDaniel and against Defendant City of Billings on Count I of Plaintiffs' Complaint according to the following paragraphs.

2. The "franchise fees" which are the subject of this lawsuit are unlawful.

3. Any provisions in the Subdivision Improvement Agreement relating to Plaintiffs'

property and purporting to obligate Plaintiffs to pay an illegal sales tax are unenforceable.

4. Defendant City of Billings, its officers, agents, servants, employees, or persons in active

concert with any of them, are ENJOINED from imposing these illegal sales taxes in the future on

Plaintiffs.

5. Pursuant to Rule 54 M.R.Civ.P., this is not a final judgment.
