On March 1, 2022, the Court entered a Decision and Order on the City of Billings' Motion for Partial Summary Judgment Pursuant to Mont. R. Civ. P. 56 Re Plaintiffs' Contract Claims Under Mont. Code Ann. § 30-2-607. C.t Doc. 106. The Court granted the City's Motion for partial summary judgment dismissing Plaintiffs' water claims. The Court held that pursuant to § 30-2-607, MCA, Plaintiffs' water claims for breach of contract and breach of the covenant of good faith and fair dealing were dismissed. Based upon the Court's Decision and Order, the Court enters the following partial summary judgment:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. Partial Summary Judgment is entered in favor of Defendant City of Billings and against Plaintiffs Gary McDaniel and Susan McDaniel on Plaintiffs' water claims under Counts II and III of Plaintiffs' Complaint. Counts II and III as to Plaintiffs' water claims are DISMISSED, with prejudice.

2. Pursuant to Rule 54 M.R.Civ.P. this is not a final judgment.
